REVIEW OF AMEMDMEMTS TO PLAN

Board members are in receipt of a memo from DEC Land Specialist Ingrid Haeckel addressing the amendments to the Community Preservation Plan. The reports states that nearly a third of the parcels used for the scoring analysis had errors. The parcels were located in the SP zoning area. The errors have been corrected.

Councilmember Wiegand commented that the Town is moving too quickly on this and his opinion is validated by the errors identified. Mr. Wiegand feels it would be prudent to move forward bur to schedule the referendum for next year.

SEQR REVIEW

Board members along with attorney Christine Chale reviewed the Part 2 questions 1-18 and narrative for the SEQR form. It was determined that this project will have no significant impact and the Board declared a Negative Declaration. The following Resolution was adopted:
