ICE STORM THIS LAST WEEKEND

The Town of Gardiner fared well with the ice storm this last weekend. Although many part of Ulster County were greatly affected. Over 80 Poles were damaged and approximately 2500 electrical lines were down. 900 linemen have been working tirelessly to restore power.

RAIL TRAIL REPAIR

OSI is moving forward with the repair of the Rail Trail in Gardiner. Bid packages are going out and they have asked for a letter of support from the Town of Gardiner.

PUBLIC HEARING - KENNEL LAW

At 7:05 PM a public hearing was held regarding the Kennel Local Law. The Town Clerk read the notice and Supervisor Majestic opened the hearing to the public for questions and comments. Councilmember Richman is concerned with the broad statement on commercial breeding. Asked to change the definition. Board members agreed.

Supervisor Majestic stated that she has received a no comment from the Town of Gardiner Planning Board and No County Impact from the Ulster County Planning Board.

CLOSE PUBLIC HEARING

On motion of Councilmember Walls, seconded by Councilmember Richman and carried, the public hearing for the Kennel Local Law was closed at 7:24 PM.

SEQR REVIEW AND NEGATIVE DECLARATION

Supervisor Majestic reviewed the FEAF Part 2 with the Town Board. It was determined that the local law will not have any environmental impact and a Negative Declaration was declared. Resolution No. 66 - Negative Declaration and Adopting a Proposed Local Law to Regulate Kennels in the Town Of Gardiner - OOffered by Councilmember Walls

WHEREAS, a new version of the proposed local law entitled, "Kennel Law of the Town of Gardiner, Ulster County New York", was introduced by the Town Board in December 2021, and WHEREAS, as the proposed action involves the adoption of a local law and no other necessary approvals, the Town Board assumed the Lead Agency under SEQRA pursuant to 6 NYCRR 617.6(b)(1) and determined the proposed local law would be reviewed as a Type I action under SEQRA; and

WHEREAS, the Town Board forwarded the proposed local law to the Ulster County Planning Board and Town of Gardiner Planning Board for its review and comment, and duly noticed and held a public hearing on the proposed local law; and

WHEREAS, the Town Board has duly considered the local law, the contents of the Full Environmental Assessment Form (EAF) for the proposed local law and completed Parts 2 and 3

thereof; and

WHEREAS, the Town Board has taken a "hard look" at the relevant areas of environmental inquiry and did not identify any potential significant adverse impacts related to the revised local law

Now Therefore, Be It Resolved as Follows by the Town Board of Gardiner, Ulster County, New York:

THAT THE Town Board of the Town of Gardiner hereby determines that the adoption of Local Law No. 1 of 2022, will not result in any significant adverse environmental impacts and authorizes filing of the Completed SEAF Part 3 with reasoned elaboration supporting a Negative Declaration in accordance with SEQRA, 6 NYCRR Part 617; and

ADOPTION OF KENNEL LOCAL LAW

Resolution Adopting Local Law No. 67- Kennel Law of the Town of Gardiner Offered by Councilmember Carucci

WHEREAS, the Town Board of the Town of Gardiner has introduced a proposed local law entitled, "Kennel Law of the Town of Gardiner, Ulster County New York"; and

WHEREAS, the Town Board has caused the local law to be referred to the Town and County Planning Board; and

WHEREAS, the Town Board duly noticed and held a public hearing on the proposed local law on February 8, 2022; and

WHEREAS, the Town Board reviewed and considered the public comments received on the proposed local law; and

WHEREAS, the proposed local law was on file for inspection at the Clerk's office prior to the hearings and during the public review process; and

WHEREAS, the Town Board of the Town of Gardiner has determined that the adoption of the proposed local law, will not result in any significant adverse environmental impacts; and

WHEREAS, the Town Board has adopted a Negative Declaration under SEQRA and directed the Town's consultant file the same; and

Now Therefore, Be It Resolved as Follows by the Town Board of the Town of Gardiner, Ulster County, New York:

THAT THE Town Board hereby determines that proposed Local Law No.1 of 2022 (attached hereto and made a part hereof), is hereby adopted; and

IT IS FURTHER RESOLVED, that the Town Clerk and the Attorney for the Town are hereby directed to take such actions as are necessary to implement this resolution. Seconded by Councilmember Richman and carried.

COMMUNITY PRESERVATION FUND - ATTORNEY

Chairman of the Open Space Commission Jean McGrane was present to speak to the Board about hiring an attorney for assisting in the creation of the Local Law and procedures for the Community Preservation Plan. Ms. McGrane is recommending Christine Chale with Rodenhousen & Chale. A motion was made by Councilmember Walls, seconded by Supervisor Majestic and carried, engaging the services of Christine Chale to assist with the creation of the local law and procedures for the Community Preservation Plan not to exceed \$7500.

PARKS AND RECREATION COMMITTEE & COMPREHENSIVE PLAN

Ilka Casey was present representing the Parks & Recreation Committee and to give an update on their goals for inclusion in the Comprehensive Plan. The discussion evolved into a discussion about the Comprehensive Plan. Councilmember Walls commented that the Comprehensive Plan is a vision for the Town and is not designed for specific departments. It's a guiding document and if it is too dense it won't be used properly. This document will bring about changes to our zoning law.

Supervisor Majestic sees 3 tweaks to the Plan: 1.) The vision statement; 2.) In chapter 3 – the NRI should be referenced as a guiding document; 3.) the Stretch Energy Code. The discussion then returned back to the Parks & Recreation committee. Ms Casey outlined the items that still need attention at the basketball court. The surface needs to be painted and she is awaiting quotes and the gravel needs to be higher.

At 8:30 PM Councilmember Walls left the meeting.
