Baseline Inventory

Sent the names of two additional consultants to the town board who can do Baseline inventory

Heartwood was approved pending the completion of a baseline inventory. The Shaft Road Conservation Easement was approved by the Town Board (TB) prior to obtaining the research and information presented by the Gardiner Open Space Commission regarding the necessity of completing a Baseline Inventory prior to the TB's acceptance of the Conservation Easement. The Town Supervisor has been in communication with the property owner to complete the Baseline Inventory.

Review and revise Town law on open space preservation

Prioritization of Conservation Efforts

- Kay sent out one final one that is easier to use more like New Paltz
- NP has scenic and cultural resources; Gardiner doesn't include project viability
- New Paltz one gives a lot of discretion to what you rank within them but are emphasizing project viability and farm viability a lot
 - 21% project viability
 - 21% for farm viability
- Combine Gardiner and New Paltz
- Might need to make some recommendations on how to score on the 1-10 scale on the New Paltz criteria Gardiner gives slightly more guidance
- NRI maps like biodiversity can be really helpful in ranking priorities
- How to move forward with it?
 - Is there information that is not included?
- Like the additional scoring guidance Gardiner gives less discretion in terms of scoring
- Next Steps Subcommittee to create a new version
 - Laura WP, Becca, Kellie
 - Come up with proposed new version
 - Becca to make it word from pdf

New conservation efforts – moving forward

- New funding might come up through \$3billion bond act approved by the legislature
- What to present to the public about the NRI presentation could be a presentation on a set of maps
 - Help the public understand why it's important to them

- $\circ~$ Have our message included in the presentation could say part of Open Space Acquisition Program
- \circ ~ Use the maps to show examples of how it would inform a particular decision
- Jean will send Roberta's email of her suggestions for the NRI presentation to the team
- We could do some education and outreach during this shelter at home time and start to introduce who we are
 - Could show some NRI maps
- We could do some educational webinars about who we are and then roll out some of our program to solicit conservation interests and potential donations and properties
- Jean will develop a timeline for outreach meetings with goals and objectives for those meetings
 Could use breakout rooms on Zoom to do small group meetings
