January 11, 2022 – Regular Meeting

The regular meeting of the Gardiner Town Board was held this evening at 7 PM. This meeting was conducted on Zoom as a virtual meeting. Present were Supervisor Majestic, Councilmembers Carucci, Richman, Walls and Wiegand. There were approximately 39± audience members.

ANNOUNCEMENTS

January 15 – Town Hall and Highway Dept will be closed in observance of Martin Luther King Jr. Day.

February 20-23 - 2022 Annual Association of Towns meeting. The meeting will be held virtual and the cost is \$100 per person.

COVID UPDATE

Covid cases in Gardiner have gone up from 99 cases to 164 cases in one week. Supervisor Majestic tested positive last week. To err on the side of caution it was decided to return to virtual meetings.

ELECTRICIAN LICENSE

As of January 1, 2022 all electricians doing work in Ulster County must be licensed by Ulster County. The law was adopted in the fall and enforcement began on the first.

CLOVE RD BRIDGE

The new bridge for the Clove Rd. bridge repair will be delivered tomorrow. The project is moving ahead. No word on when it will be finished.

MAJESTIC PARK SKATING RINK

The ice has now frozen on the skating rink and families are using it much to the delight of the Town Supervisor.

KENNEL LOCAL LAW-SCHEDULE PUBLIC HEARING

Board members scheduled a public hearing on the adoption of a Kennel Law which will ban commercial kennels among other things for February 8, 2022. A motion was made by Councilmember Walls, seconded by Councilmember Carucci and carried.

RESOLUTION KENNEL MORATORIUM EXTENSION – LOCAL LAW

In the event the Kennel Law is not adopted at this meeting the Town Board agreed to extend the moratorium on permits for a kennel. A public hearing on this extension was also scheduled for February 8, 2022 on motion of Councilmember Richman, seconded by Councilmember Wiegand.

Resolution No. 50 - Resolution Scheduling a Public Hearing on Proposed Local Law to Further Extend a Moratorium on the Processing and Approval of Permits for Kennels in the Town of Gardiner for an Additional Three (3) Month Period

Offered by Councilmember Richman

WHEREAS, A proposed local law entitled, "Local Law to Further Extend a Moratorium on the Processing and Approval of Permits for Kennels in the Town of Gardiner for an Additional Three (3) Month Period", was introduced at a meeting of the Town Board held on January 11, 2022; and

NOW, THEREFORE, BE IT RESOLVED, that said Town Board shall hold a Public Hearing at the Town Hall, 2340 Rt. 44/55, Gardiner, New York, on February 8, 2022 at 7 P.M., to hear all persons interested in the matter of the adoption of the proposed local law, and be it

FURTHER RESOLVED, that the Town Clerk is hereby authorized and directed to publish notice of said special meeting and public hearing in the Times Herald Record and to post copies of such notice in the manner provided by law, and be it

FURTHER RESOLVED, that the Town Clerk and the Attorney for the Town are hereby authorized and directed to refer the proposed local law and/or Notice of Public Hearing to the appropriate agencies for their review and recommendations.

Seconded by Councilmember Wiegand and carried.

SHORT-TERM RENTAL LOCAL LAW

A public hearing was held in November on the Short-term Rental Local Law. At the end of the hearing, it was closed and Board members were looking for clarification on several points in the law. They discussed LLC's, appointments by the building inspector, the 90-day license requirement and owner-occupied versus non-owner-occupied rental among other details of the law. Councilmember Walls stated that the Town no longer needs a stop-gap measure as the purpose of the law has been achieved. Town Clerk Michelle Mosher pleaded with the Town Board to delay the vote. She explained that at this point she is in the midst of a very busy tax collection season and not to mention, has not received an application to give to anyone as well as any information the Town Board would like in the information packet. The Town is not prepared to begin this process. A motion was made by Councilmember Wiegand, seconded by Supervisor Majestic and carried to postpone the vote on the law to either the first or second meeting in March. Councilmembers Walls and Richman were opposed.

RESOLUTION SENIOR CITIZENS INCOME EXEMPTION

Resolution No. 51 - Senior Citizen & Persons with Disabilities & Limited Income Exemptions - Offered by Councilmember Carucci

Whereas, due to the concerns regarding COVID-19 and to protect the health of vulnerable individuals,

Now, Therefore, Be It Resolved, that pursuant to the New York State Governors Executive Order 11.1 issued December 26, 2021 the Town of Gardiner will not require property owners receiving Senior Citizens or Persons with Disabilities & Limited Income Exemptions to file renewal applications for the 2022 Assessment Roll. If the property owner would benefit from filing applications, the assessor may require the filing of the renewal applications. Seconded by Councilmember Wiegand and carried.

COMMUNITY PRESERVATION PLAN

Open Space Commission chairman Jean McGrane spoke to the Town Board in support of Ted Fink of Green Plan to prepare the Town of Gardiner's Community Preservation Plan. Ms McGrane spoke on his expertise and his ability to get this done before the end of June. On motion of Councilmember Wiegand, seconded by Councilmember Walls and carried, Supervisor Majestic was authorized to hire Ted Fink as the planner for the Community Preservation Plan. Resolution No. 52 – Supporting Development of a Community Preservation Plan Offered by Councilmember Walls

WHEREAS, The Town of Gardiner is distinguished by its unique landscape setting, including the Shawangunk Ridge, the Wallkill River Valley, woodlands, wetlands, farmland, scenic features; and

WHEREAS, Gardiner's natural beauty and open spaces are fundamental to our unique community character and are integral to our landscape and sense of place;

WHEREAS, the protection of our natural resources provide clean water, fresh local food and resiliency in the face of climate impacts; and

WHEREAS, these features contribute to the quality of life for all Gardiner residents and visitors and are important to the economic future of the community; and

WHEREAS, The Town's Comprehensive Plan, Open Space Plan and Natural Resource Inventory call for additional protection of these resources in the face of encroaching development; and

WHEREAS, New York State has recently enacted a Community Preservation Act which enables communities that have a Community Preservation Plan to create a Community Preservation Fund for open space and historic resources, derived from a local Real Estate Transfer Tax;

WHEREAS, Gardiner's existing plans can be updated and consolidated into a single Community Preservation Plan in accordance with the criteria set by the Community Preservation Act; and WHEREAS, with a Community Preservation Plan our community will be eligible to establish a Community Preservation Fund, if approved by the community by referendum. THEREFORE, the Town will:

Create an ad-hoc committee, made up of members of the Environmental Conservation Commission and Open Space Commission, and other interested residents to carry out the following activities:

- Draft a comprehensive Community Preservation Plan based on Gardiner's existing planning documents for adoption by the Town Board that will identify open space, farmland and cultural resource priorities;
- Educate the public about Gardiner's natural and cultural priorities, funding needs and potential opportunities for a new funding source;
- Evaluate and make recommendations about the opportunity to participate in New York State's Community Preservation Act and make recommendations on a referendum to enact a Community Preservation Fund

NOW THEREFORE, BE IT RESOLVED BY THE TOWN Board that it is the legislative policy of the Town to consider, evaluate, and support the adoption of these proposed activities.

BE IT FURTHER RESOLVED that the Supervisor, upon the advice of the Board shall charge the ad-hoc committee to make recommendations to the Board and to the Supervisor regarding open space, farmland and cultural resources, and funding for their protection. BE IT FURTHER RESOLVED that the committee will explore technical, environmental, and economic considerations to aid the community in selecting protection priorities and funding sources.

BE IT FURTHER RESOLVED that the committees, the staff of the Town, and Town consultants should develop plans to implement appropriate practices so that the Town can continue to be a conservation leader, and an outstanding steward of our irreplaceable resources Seconded by Councilmember Richman and carried.
