### **Revenue-General Budget:**

Increase Ulster County Sales Tax from \$320,000.00 to \$350,000.00 Decrease Mortgage Tax from \$225,000.00 to \$200,000.00 Line Added- Wireless Edge Rent- \$42,790.00/per year Increase Summer Rec from \$82,500.00 to \$84,350.00 Increase Building and Alterations from \$75,000.00 to \$120,000.00

On the motion of Councilmember Wiegand, seconded by Councilmember Walls and carried to adopt Local Law 2- Tax Cap Override. Councilmember Richman was absent.

#### **HIGHWAY DEPARTMENT REQUEST**

Superintendent Stiscia has formally requested the Town Board to carefully consider the addition of an extra employee to the Highway Department. It is with great concern that he highlights the mounting workload and increased responsibilities that have burdened the department. In particular, Mr. Stiscia has brought to the Board's attention that one of the Highway employees has received orders of deployment for 9-12 months in the Marine Reserves, commencing in 2025. The Highway Department requires an individual who possesses a unique set of skills and qualifications, making the search for a responsible and capable candidate all the more difficult. The Board has requested Brian to provide them with a comprehensive list of responsibilities that the Highway Department undertakes. This will enable the Board to gain a deeper understanding of the department's needs and facilitate their decision-making process.

## **OTHER BUDGET ITEMS**

Councilmember Walls addressed the Board her concerns regarding records storage and potentially adding an addition to the Town Hall.
