Resolution No. 61- Appropriate Funds from the Town's ARPA Coronavirus Local Fiscal Recovery Fund

Whereas, on July 1 2021 the Town of Gardiner was notified by the NYS Division of the Budget of its eligibility for funding of \$576,486.71 under the ARPA Coronavirus Local Fiscal Recovery Fund;

Whereas, the roads in the Town of Gardiner are used by all;

Whereas, the Town of Gardiner has purchased a 2023 Caterpillar Excavator for the Highway Department to use for road repairs and maintenance for \$172,500.00.

Whereas, the Town Board chose a payment option that requires a 10% down payment of \$17,250, with three annual payments of \$57,193.95 to be paid in October of 2023, 2024 and 2025.

Whereas, the 2023 budget for the Town of Gardiner did not include the 10% downpayment; Whereas, the Town Board has agreed to transfer the \$17,250 from the ARPA Coronavirus Local Fiscal Recovery Fund to the Highway Fund.

Now, therefore be it resolved that the Town Board of the Town of Gardiner hereby agrees to transfer the \$17,250 from the ARPA Coronavirus Local Fiscal Recovery Fund to the Highway Fund to make the down payment payable to H.O. Penn for the 2023 CAT Excavator. Seconded Councilmember Carucci and carried. Councilmembers Wiegand and Walls were absent.

MOTION AUTHORIZING SUPERVISOR TO SIGN UPSEU COLLECTIVE BARGAINING UNIT
